



ESM Local User Account Application

This form is for Penn State Faculty, Staff, or Students to request a local computer account from the ESM Department. While this is a separate account, your user ID will match that of your Penn State Access Account, and cannot be changed once created. The user ID and password assigned to you will enable you to log on to one or more computers listed on this form. Return the completed form to the IT Staff in 212 EES Building.

To pick up your Local Account user ID and password, allow two business days for processing after submitting this form. You may pick up your account ID and password by presenting photo ID to ESM IT staff at 307D Earth and Engineering Sciences Building. You may change your password separately on each computer that you are authorized to access.

Take great care in safeguarding your password, and please be aware that it will expire every 365 days

Your password must contain at least 8 characters (more preferred) with 3 types of characters: lower-case letters, upper-case letters numbers and punctuation. Your password may not contain your first name, last name or user ID. You may not use any of the last 24 passwords when changing your password.
